Previous minutes

1. The SPCB agreed the minute of the meeting held on 26 October 2023.

Matters arising

2. No decisions had been taken by correspondence since the last meeting. Updates had been circulated for noting on matters including: car park access arrangements; future Members' surveys; correspondence; and the appointment of an adviser to the Net Zero, Energy and Transport Committee.

Parliamentary travel – Paper 67

 The SPCB agreed a request for travel costs to be met from the Members' Expenses Scheme. The SPCB also requested that officials bring a paper to a future meeting for further discussion around costs incurred by Members relating to Cross Party Group activities.

Digital project investment planning – Paper 68

4. The SPCB received an overview of digital project investment. The SPCB noted the project pipeline covering the remainder of the session, the estimated budgetary requirements that would feature in the SPCB's budget bid, and the governance arrangements in place for the projects.

Resource allocation for 2024-25 budget and future years

5. The SPCB discussed indexation options for both 2024-25 and 2025-26. Modelling would be undertaken based on the indices presented and these would be further discussed ahead of a finalised budget bid being presented for sign-off in December.

- 7. The SPCB also considered a request from the Electoral Commission and asked officials to set up a meeting with the Commission to facilitate further discussion.

8. The SPCB discussed proposals aimed at helping to reduce the organisation's travel emissions. Additional information was requested to support further discussions at a future meeting.
