

# International Relations: Overview of activity, January 2022 - 31 March 2023 4 May 2023

Reference: SPCB (2023) Paper 33

# **Executive summary**

1. The International Strategy agreed by the SPCB in September 2021 stated that the International Relations Office (IRO) would produce a twice-yearly overview of the core international work undertaken by the Scottish Parliament. Normally the report would cover a six-month period but this report, for completeness, covers all activity since January 2022 until 31 March 2023 as no report has been provided since then due to change in staff. No SPCB decision is being sought.

# Issues and options

- 2. Annexed is a list showing the activity in the period of this report.
- 3. In March 2020, all planned inward and outward international visits were cancelled by the IRO at the outset of the pandemic. Limited engagement activity took place online during the restrictions. However, with an easing of restrictions from early 2022, IRO has engaged in supporting both inward and outward visits and, whilst we aren't quite at pre-pandemic levels, we are moving in that direction.
- 4. As discussed previously with the SPCB, in considering its new International Strategy, a key benefit from the focus on

developing direct friendships and relationships with other legislatures and organisations allowed the IRO to quickly and easily approach others interested in the same or similar policy, procedural or corporate issues. For example, the Presiding Officer's outward visit to Lower Saxony in June 2022 allowed her to meet with her counterpart, enabling sharing of experiences and knowledge on the management of parliamentary business. This included seating arrangements in the Chamber; how Members request to speak and make points of order; timing of speeches; IT systems in the Chamber; maintaining impartiality; maintaining respect in proceedings; responding to COVID; broadcasting and public access; and many other matters relevant to the roles.

- 5. The key task for the IRO is to make the SPCB's focus on 'interparliamentary co-operations' work at a practical level, generate ideas around new ways of working and share experience, knowledge and practices.
- 6. Other international work managed by the IRO includes supporting the Commonwealth Parliamentary Association (CPA) Scotland Branch and the Scottish delegation to the British Irish Parliamentary Assembly. The composition of each:
- CPA Scotland Branch Executive Committee: Jeremy Balfour MSP, Sarah Boyack MSP, Stuart McMillan MSP (Branch President: Presiding Officer).
- BIPA: Deputy Presiding Officer Annabelle Ewing MSP, Willie Coffey MSP, Ross Greer MSP, Pauline McNeill MSP, Tess White MSP.
- 7. Since March 2023, IRO has taken on the responsibility of supporting the Parliament's delegates to the Council of Europe's Congress of Local and Regional Authorities (CLRAE) as well as the Committee of the Regions UK contact group (CoR). The composition of the delegation to each is:

- CLRAE: Ben MacPherson MSP, full member, and Maurice Golden MSP, substitute member.
- CoR: Alasdair Allan MSP, full member, and Sarah Boyack MSP, substitute member.

### Governance

- 8. The IRO is responsible for the development and implementation of the International Strategy. While it facilitates most inward, outward and virtual international visits, it is not involved in every such engagement e.g. those undertaken by committees as part of an inquiry or by MSPs on cross party groups. This paper therefore does not reflect all international activity taking place, only that supported by the IRO.
- 9. The current International Strategy built on the experiences and practices applied by the Parliament in developing its international relations approach. The continued link of the Strategy to the Parliament's Strategic and Delivery plans and the focus on the procedural, corporate and policy interests of the institution allows the IRO to better plan activity, provides a more efficient link to resources and secures practical benefits. In short, it allows the Parliament to more easily identify what it wants to do, why, and when.

# **Resource implications**

10. There are no resource implications arising from this paper.
All activity was accommodated from within the IRO budget.

### **Publication Scheme**

11. This paper will be published in line with the SPCB's Publication Scheme. The IRO is considering how it might better present to the SPCB the information annexed to this paper e.g., through the use of infographics.
