

International Relations: Overview of activity, April 2023 - 31 January 2024 8 February 2024

Reference: SPCB (2024) Paper 10

Executive summary

1. The International Strategy agreed by the SPCB in September 2021 stated that the International Relations Office (IRO) would produce a twice-yearly overview of the core international work undertaken by the Scottish Parliament. Normally the report would cover a six-month period but this report, for completeness, covers all activity since April 2023 until 31 January 2024. No SPCB decision is being sought.

Recent Activity

- 2. Annexed is a list showing the activity in the period of this report.
- 3. IRO supports the Parliament's engagement with other parliaments across the world. Naturally, the most substantial engagement tends to be with those legislatures with which the Parliament has a historic relationship, those who proactively seek to engage with us, those that have similar size and characteristics as the Scottish Parliament (including those studied by the Consultative Steering Group for the establishment of the Parliament) and those where there is potential for mutual benefit from working together.
- 4. As an example, the Scottish Parliament has strong relationships with the Parliament of Canada and a number of Canada's provincial legislatures. In April 2023, the Presiding Officer led a delegation to visit the Parliament of Canada in Ottawa and the National Assembly of Québec, alongside taking part in the annual Scotland Week events in New York. The visits to both of these legislatures included discussions on a range of issues of mutual interest and provided a valuable opportunity to observe and learn from different approaches to parliamentary question times.

- 5. The IRO is continuing to support both inward and outward visits in order to deliver the International Strategy. As a result of focusing on geographical areas and developing bilateral relationships, we were pleased to welcome, Bjørt Samuelsen, Speaker, and Presidium of the Parliament of the Faroe Islands visited the Scottish Parliament.
- 6. The delegation met with the Presiding Officer, both Deputy Presiding Officers, Members and officials. During their visit they discussed parliamentary proceedings, organisational structure and the Parliament's BSL services and plan. The Speaker also gave a presentation on the Løgting, the Parliament of the Faroe Islands, to MSPs. Following this visit, in November Deputy Presiding Officer Annabelle Ewing MSP met with the Second Deputy Speaker of the Faroese Parliament at the Nordic Council Session in Oslo, speaking about common interests and potential collaboration.
- 7. In addition to inward and outward visits, the IRO has been focusing on developing strategic relationships with organisations such as the Westminster Foundation for Democracy and the National Democratic Institute (NDI). By working with these organisations, which seek to strengthen democratic institutions around the world, the Parliament can engage in mutual learning with a wide range of parliaments and can provide continuous professional development opportunities for both Members and officials, one of the key elements of the International Strategy.
- 8. Under the auspices of the NDI, and its 'Parliament Support Programme', IRO supported Financial Scrutiny Unit (FSU) officials to visit Skopje, North Macedonia in April 2023 to provide assistance to the newly established Parliamentary Budget Office (PBO) in the Assembly of the Republic of North Macedonia. The PBO's aim is enhance parliamentary financial oversight and its scrutiny function and it is very much modelled on our own FSU. A reciprocal visit to Holyrood was made by PBO officials in May 2023, during which they met with the Clerk/Chief Executive, party finance spokespersons, committee clerks, SPICe, and a range of external stakeholders such as the Scottish Fiscal Commission, Audit Scotland and the Fraser of Allander Institute.
- 9. Other international work supported by the IRO includes supporting the Scottish delegation to the British Irish Parliamentary Assembly (BIPA) and the Commonwealth Parliamentary Association (CPA) Scotland Branch. The delegation to BIPA is led by Deputy Presiding Officer Annabelle Ewing MSP, and comprises Emma Harper MSP, Ross Greer MSP, Pauline McNeill MSP, Tess White MSP.

- 10. The CPA Scotland Branch Executive Committee comprises Jeremy Balfour MSP, Sarah Boyack MSP, and Stuart McMillan MSP and all MSPs are member of the CPA Scotland Branch.
- 11. The Parliament's delegation to the British Irish Parliamentary Assembly (BIPA) participated in the 64th Plenary Session in Jersey in May 2023. Plenary discussions focussed on the post-Brexit relationship between the UK and Ireland, with an address from the Minister of State for Northern Ireland, Steve Baker MP. The delegation also heard from the Chief Minister of Jersey, Deputy Kristina Moore, and the Bailiff of Jersey and President of the States Assembly, Timothy Le Cocq K.C.
- 12. In October 2023, the Scottish Parliament hosted the fourth CPA Advanced Parliamentary Development Residency Course. Twenty-six parliamentarians from across the Commonwealth attended the course to enhance their skills as parliamentarians. This also involved some MSPs supporting the course as mentors and speakers. The course, and the Parliament's hosting of it, received positive feedback received from the delegates.
- 13. The 52nd conference of the British Irish Mediterranean Region of the CPA took place in Westminster, London from 25-27 April 2023. The delegation from the Scottish Parliament consisted of Jeremy Balfour MSP, member of the Scotland Branch Executive Committee and CPwD Network; Sarah Boyack MSP, member of the Scotland Branch Executive Committee and CWP BIMR Steering Committee; Gillian Mackay MSP; Stuart McMillan MSP, member of the Scotland Branch Executive Committee and Regional Representative on the CPA ExCo; and Michelle Thomson MSP, member of the CWP BIMR Steering Committee.
- 14. The members took part in all sessions over the three days. Sarah Boyack MSP chaired the Parliamentary Movements to Address the Climate Emergency plenary, Jeremy Balfour MSP was a panellist on the Inclusive Parliaments plenary and Stuart McMillan MSP provided members with an update from the CPA Executive Committee at the Annual General Meeting. The conference allowed for in-depth discussion and shared learning across a range of parliaments and topics. Members particularly found it useful sharing best practices and developing relationships with colleagues across the region, enhancing their work as parliamentarians. Outcomes

15. The IRO is keen to ensure that the benefit realised from both inward and outward visits is fed back into Parliament to ensure wider learning across the Parliament. All Members going on outwards, will be asked to provide feedback within 2 weeks of returning from an outward and again 6 months

later. This will enable the IRO to understand what learning has been implemented across Parliament. All inward visit delegations are sent an evaluation form to complete after their visit.

16. In January 2023 a number of MPs who sat as part of the Speaker's Conference on the Employment Conditions of Members' Staff visited Parliament. They were here to meet and discuss with Members and officials the way in which the Scottish Parliament manages its relationship with Members and Members' staff, and to see what the Westminster Parliament could learn. The report was published in July 2023, and a paper taken to the commission on 23 October. A debate took place on 16 November in the house of commons, where Hon Clive Efford MP stated:

"We went to the Scottish Parliament and looked at the way it arranges its scrutiny of finances and provision of support to Members of the Scottish Parliament. I have to say that the Scottish approach impressed me no end. The people there understood that they were there to assist the MSPs in their role, but none the less there was a set of rules that MSPs had to adhere to. We need to move to a system similar to that."

17. Feedback from the Speaker's Conference was:

'The visit was very successful, and the members of the Conference found the information they were given made a very constructive impact on the way on the recommendations in the Conference report itself. In particular, the way in which the Scottish Parliament run their Member insurances, the interaction between the HR service and Members' staff and the support Members' staff receive, and way Members are trained and supported in their role as employers all helped shape the report.'

- 18. Kaukab Stewart MSP, delegate, and Stuart McMillan MSP, Member of CPA Executive Committee, represented the Scottish Parliament at the 66th Commonwealth Parliamentary Conference in Accra Ghana. "The Commonwealth Charter 10 years on: Values and principles for parliaments to uphold." The conference was attended by more than 600 delegates and took place 1 5 October 2023.
- 19. Kaukab Stewart MSP was also a panellist on the workshop "The Commonwealth Charter: A Charter for all human rights, or just some?". In addition to the conference agenda the two Members had six bilateral meetings with Speakers, Members and academics from Québec, Kwazulu-Natal, New South Wales, Victoria, New Zealand and Commonwealth Parliamentary Association HQ. One of the members said 'My own confidence levels have increased, and I am already able to apply my

knowledge and skills during my committee work and how I take part in debates?

- 20.31 October- 2 November 2023 Deputy Presiding Officer Annabelle Ewing MSP, Beatrice Wishart MSP and Ben Macpherson MSP represented the Scottish Parliament at the Nordic Council Session in Oslo, Norway. The theme of the Session was "A secure, green and young Nordic Region'. The Session included 700 delegates from the eight Nordic countries and international guests from a further ten legislatures and international organisations. The Deputy Presiding Officer spoke to the Chamber highlighting the close connection we share with the Nordic Region and wish to collaborate with them more in the future.
- 21. In addition to attending the Session the DPO and two Members held seven bilateral meetings with Deputy Speakers, Presidents and Committee Chairs from Sweden, Faroe Islands, Norway, Baltic Sea Parliamentary Conference and the Nordic Council presidium and secretariat. Since returning from Oslo, Ben MacPherson MSP, Member of Net Zero, Energy and Transport Committee has written to the chair of the Committee for a Sustainable Nordic Region of the Nordic Council suggesting further areas of collaboration.
- 22. Monica Lennon MSP and Mark Ruskell MSP attended the annual Arctic Circle Assembly in Reykjavik on behalf of the Net Zero, Energy and Transport Committee. This was the fourth time the Parliament has had representation at this annual gathering but the first occasion where MSPs delivered a breakout session alongside elected Members of another Parliament (Members of the Icelandic Parliament's Environment and Communications Committee). The session, titled "Views from Parliamentarians from Scotland and the Nordic Region on the challenges of meeting wind energy and biodiversity ambitions" was well attended by a diverse group of international parliamentarians, academics, NGOs and others. The session was well received and, due to the large number of questions asked by members of the audience, went over the allocated time.
- 23. As the largest annual international gathering on the Arctic, the Assembly provides a unique opportunity to attend a number of workshops and discussions on topics of direct relevance to Scottish Parliament committees. Just as importantly, however, is the opportunity this annual gathering of Ministers, parliamentarians, NGOs, academics etc provides to hold bi-lateral meetings on subject matters of direct and topical relevance to members of the Scottish Parliament delegation. As before, bilateral meetings were arranged by IRO with Ministers in the Icelandic Government, international parliamentarians and others. One of the members said 'I really valued the Assembly as it was a great professional development opportunity for Members'

Governance

- 24. The IRO is responsible for the development and implementation of the International Strategy. While it facilitates most inward, outward and virtual international visits, it is not involved in every such engagement e.g. those undertaken by committees as part of an inquiry or by MSPs on cross party groups. This paper therefore does not reflect all international activity taking place, only that supported by the IRO.
- 25. The current International Strategy built on the experiences and practices applied by the Parliament in developing its international relations approach. The continued link of the Strategy to the Parliament's Strategic and Delivery plans and the focus on the procedural, corporate and policy interests of the institution allows the IRO to better plan activity, provides a more efficient link to resources and secures practical benefits.
